We are project managers, facilitators of knowledge exchange, and supporters of European projects that connect people and cultures. In short, we are EACEA.

**Erasmus+** is the EU's programme for supporting education, training, youth and sport in Europe. Through Erasmus+, we support projects that give individuals the chance to study, train, gain work experience and volunteer abroad, and which help organisations to take part in transnational partnerships.

At EACEA we also manage the Erasmus+ programme's Eurydice network, which provides reliable and comparable information on European education systems and policies, as well as the Youth Wiki platform, which serves as Europe's online encyclopaedia of national youth policies. We publish numerous studies and analysis of education systems and youth policies each year.
